How it all began...Swift Current Creek Watershed Stewardship

Information Source: meeting minutes from 1998 to 2002

November '98:

A group of government representatives meet to address water quality concerns raised by the City of Swift Current.

January '99:

A review of the water quality information shows no obvious decrease in quality but the group feels that promoting stream stewardship values and increasing water quality monitoring would still be a beneficial activity because of public concerns regarding water quality.

March '99:

An effluent spill from the City of Swift Current lagoons into the creek.

January '01:

A public informational meeting is held and representatives from all areas of the watershed attend. A steering committee is appointed to discuss future options for a stewardship group. June '01:

The Steering Committee names the group the "Swift Current Creek Watershed Stewards" (SCCWS) and decides on the groups' mission statement and goals. The first publication is released, introducing the concept of watershed stewardship.

September '01: The first SCCWS General Meeting. A Board of Directors is formed, and the SCCWS apply for program funding.

November '01:

The SCCWS receive funding under the Agricultural Environmental Stewardship Initiative of CARDS and is formally incorporated as the Swift Current Creek Watershed Stewards

February '02:

The SCCWS hires a coordinator to start the first education and awareness program year.






