

FINANCIAL REPORT

The Swift Current Creek Watershed Environmental Stewardship Program received \$88.146.98 in cash commitments and \$73,211.56 as in-kind commitments for a total of \$161,358.84. The SCCWS used \$84,873.02 for the project and thus, the project had a surplus of \$3.273.96.
